


BRUCE J. BOIVIN does hereby declare, under penalty of perjury, that:

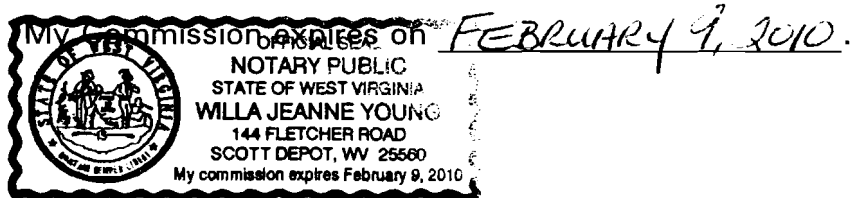


