PLEASE TAKE NOTICE that on January 4, 2008 at 9:30 a.m., at Albany, New York, or as soon thereafter as is convenient for the Court, the Defendants John Hudgens, III, Cynthia Bensch<sup>1</sup>, Tracey Green, Pamella Pinson, Edward Pritchard, Jr. and State Election Commission of South Carolina (SC Election Defendants)<sup>2</sup> shall and hereby do move before this Court for the dismissal of the Amended Complaint pursuant to Rules 12(b)(1), (2), (3), and (6), FRCP, in that, for the following reasons, the Court lacks jurisdiction over the subject matter of this action, the Court lacks jurisdiction of the person as to the SC Election Commission Defendants, venue is improper and the Plaintiffs have failed to state a claim upon which relief can be granted:

- 1. This Court lacks personal jurisdiction as to the SC Election Defendants.
- 2. The venue is improper.
