MOTION TO DISMISS

The State of Delaware and Elaine Manlove, the Commissioner of Elections for the State of Delaware, by and through her attorney, A. Ann Woolfolk, Deputy Attorney General for the State of Delaware move to dismiss this Complaint, and in support of their Motion to Dismiss, state as follows:

1. This Honorable Court lacks personal jurisdiction over the Delaware Defendants because the Delaware Defendants do not have the minimal contacts necessary to subject them to the jurisdiction of New York courts. *World-wide Volkswagon Corp. v. Woodson*, 444 U.S. 286, 291 (1980).

2. The Northern District of New York is not the proper venue for Plaintiffs' action against the Delaware Defendants. *Leroy v. Great Western United Corp.*, 443 U.S. 173, 184 (1979)

3. The action against the State of Delaware is barred by the Eleventh Amendment to

the United States Constitution. *Pennhurst v. Halderman*, 465 U.S. 89 (1984).

4. In support of their Motion to Dismiss, the Delaware Defendants adopt the arguments made by numerous other states and state election officials, and specifically the arguments set forth in Section II A, B and E of the Memorandum of Law in Support of the New Hampshire Defendants on November 14, 2007.

WHEREFORE, the State of Delaware and the Commissioner of Elections for the State of Delaware respectfully request that this Honorable Court grant their Motion to Dismiss.
